

Privacy statement Rova Marketing

Sensitive data i.e. personal data is processed through the web shop www.rovamarkeing.com. Rova Marketing states that careful handling of personal data is of great importance. Personal data will therefore be carefully processed and protected.

With our processing, we adhere to the requirements of the Data Protection Act (DPA). That also means that we:

- Clearly specify what purposes we process personal data. We do this through this Privacy Statement;
- Limit our collection of personal data to only the personal information needed for legitimate purposes;
- Ask you first for explicit permission to process your personal data in cases necessitating your permission;
- Take appropriate security measures to protect your personal data and that also require parties who process personal data on our behalf;
- Respect your right to have your personal information on your request for inspection, correction or deletion.

Rova Marketing is responsible for the data. Because our processing operations fall within the statutory exemption regulations, they are not registered with the Dutch Data Protection Authority. This privacy statement explains which personal data we collect and use and for what purpose. We encourage you to read it carefully.

Use of personal data

By using our service, you will leave certain information with us. That can be personal data. We store and use only the personal data provided by you directly, as part of the service requested, or which is clearly stating that they are provided to us to process.

We use the following data for the purposes set out in this privacy statement:

Register

In certain parts of our service you must register first. After registration, we keep using your chosen username and personal information provided by you. We will not provide third parties with your data, unless this is necessary in the context of the implementation of the agreement you have with us or if required by law. In the case of suspected fraud or abuse of our website we can hand over personal data to the competent authorities.

Disclosure to third parties

We may disclose your information to our partners. These partners are involved in the implementation of the agreement.

Social media buttons are included on our site. This allows the operators of these services, to collect your personal information.

Google Analytics

We use Google Analytics to track how visitors use our site. We have entered into a processing agreement with Google to make arrangements for dealing with our data. Furthermore, we do not allow Google to use the obtained Analytics information for other Google services.
